FOR INSERTION INTO YOUR CODE BOOK

Please make the following revisions to your “paper” copy of the City Code Book. Very shortly we will have the online version of the Code book updated with this supplement, as well as in LaserFiche, which we encourage you to utilize as it is the easiest place to search. It will also be updated to the “U” drive for those of you who still feel most comfortable looking for it there.

Ordinance No. 1252, adopted August 4, 2009, amended Chapter 2, Administration, relative administrative department head titles. Remove **Chapter 2**, Administration, page 11/12 and insert revised page 11/12.

Ordinance No. 1243, adopted March 3, 2009, also amended Chapter 2, Administration, by providing for a Hearing Officer. Remove the balance of **Chapter 2**, Administration, pages 13/14 through 17/18 and replace with revised pages 13/14 through 17/18.

Ordinance No. 1245, adopted May 19, 2009, amended Chapter 3, Alcoholic Beverages, providing for a waiver of distance requirements under unique or special circumstances. Remove **Chapter 3**, pages 23/24 and 25/26 and replace with revised pages 23/24 and 25/26.

Ordinance No. 1248, adopted July 21, 2009, repealed Chapter 5, Purchasing and Competitive Bidding, in its entirety, and adopted a new Chapter 5, Purchasing and Competitive Bidding, to update purchasing policies and procedures. Remove the entire **Chapter 5, Purchasing and Competitive Bidding**, pages 35/36 through 41/42 and replace with new Chapter 5, pages 35/36 through 41/42.

Title changes authorized by **Ordinance No. 1252**, adopted August 4, 2009, include several pages in Chapter 8. Remove **Chapter 8**, Building and Construction, page 49/50 and replace with revised page 49/50, to correct the title on page 50, Section 8.820 to read “Department of Community Development” and similarly correct Section 8.820(a).

Ordinance No. 1249, adopted July 21, 2009, repealed Chapter 9, Fire Protection and Prevention in its entirety, and adopted a new Chapter 9, Fire Protection and Prevention, to provide new and updated rules and regulations for fire protection and prevention to improve public safety for the citizens of Temple Terrace. Remove the entire **Chapter 9, Fire Protection and Prevention**, pages 67/68 through 83/84 and replace with new pages 67/68 through 83/84.

Ordinance No. 1250, adopted July 21, 2009, enacted a new section providing for a utility tax exemption for purchases of electricity and gas under certain conditions. Remove **Chapter 19**, pages 197/198 and 199/200, and replace with new pages 197/198 and 199/200.

Ordinance No. 1242, adopted March 3, 2009, corrected a scrivener's (typographical) error. Remove **Chapter 20**, page 210.3/210.4 and page 210.7/210.8 and replace with new page 210.3/210.4 and page 210.7/210.8. (Note: there is one page in between those two pages – be careful **not** to remove/lose page 210.5/210.6, which did NOT change.)

Ordinance No. 1246, adopted June 2, 2009, amended the City's delinquency charges for late payments for services to commercial accounts to be consistent with residential accounts, amended the water meter and connection charges in order to cover the actual cost of providing the service, provided reference to basic rate schedules for water and wastewater charges to be adopted by Resolution and annually adjusted, and provided for a drought surcharge to cover the actual costs and encourage water conservation efforts. Remove **Chapter 21**, pages 222/223 and replace with new page 222/223; remove pages 227/228 through 233/234 (end of Chapter) and replace with new pages 227/228 through 233/234.

Title changes authorized by **Ordinance No. 1252**, adopted August 4, 2009, include several pages in Chapter 25, Article III. Remove **Chapter 25, Article III**, pages 285/286 and 387/288 and replace with revised pages 285/286 and 387/288, to correct the titles on pages 286, 287, and 288; in addition, remove page 295/296 and replace it with the revised page 295/296, also to correct the titles.

Ordinance No. 1244, adopted March 17, 2009, amending Chapter 25, Article VI and Article IX, to implement the changes adopted in the Comprehensive Plan with the creation of the City-wide multimodal transportation district, to include standards and requirements for transportation facilities necessary to implement the Plan provisions, etc. Remove **Chapter 25, Article VI**, pages 353/354 through 367/368 and replace with new pages 353/354 through 367/368. Also, remove **Chapter 25, Article IX**, in its entirety, including pages 563/564 through 572.11/572.12 and replace with new pages 563/564 through 571/572.

The index has also been revised. Remove the current index and replace it with the revised index provided.
