SUMMARY NOTEWORTHY ACTIVITY

Assumed duties as a Marine Patrol Officer on 09/19/09, I was working 6 hours as a Marine Patrol Officer and then the last 6 hours of my shift I worked as a Street Patrol Officer. On 10/25/09 I assumed my duties as a Marine Patrol Officer on a full time schedule.

10/02/09: Patrolled the Bypass canal, Lettuce Lake and the Hillsborough River, I conducted license and fisheries inspections. Issued 5 marine warnings, and conducted 1 BSI (boating safety inspection).

10/03/09: Patrolled the Bypass canal, and the Hillsborough River, I conducted license and fisheries inspections. One fisherman was arrest for False Name to LEO, DWLS with knowledge, illegal harvest of game fish with a cast net and possession of an undersize black bass. Officer K. Smith transported the defendant to the ORJ. Issued 7 Marine citations, 3 marine warnings, and conducted 1 BSI (boating safety inspection).
